area. A group of landowners in the Mahinepua area form a group to lower predator numbers to levels where endangered native species thrive. MRHLG pays a contract trapper to achieve this end. MRHLG provides information and assistance to the wider

community.

Entity Structure MRHLG membership is in four catergories:

Full Membership = Owns property within the MRHLG boundaries. Yearly sub.
 Lifetime Member = Full membership members. No subs. Full voting rights.

- Honorary Member = Sponsor or worker. Not a property owner. No sub. No voting rights.

- Friends = Get MRHLG newsletter. Small sub. No vote.

Committee meetings are held approximately six weekly. All members may attend.

Officers = Chairman, Treasurer, Secretary, Assistant to Secretary

Main Sources of Cash and Resources Subscriptions, Donations by members, Funding grants, Fundraising activities

Main Methods Used to Raise Funds Funding Grants pay for our Trapper. We also raise funds by selling tee shirts donated by a

member.

Entity's Reliance on Volunteers and Donated Goods or Services

Without grants from various institutions MRHLG would be unable to fulfil its aims. Our contract trapper payments need more funds than MRHLG can raise from subscriptions and member and friend donations. Without a contract trapper our predator levels would be too high to continue the rise in Kiwi numbers we have achieved and the area would probably fall back into the -2% bracket for Kiwi numbers instead of the present +2%

(approx).

Additional Information All of our members (many of whom live in the district for only part of the year) receive our

newsletter and assist us whenever they can. More volunteers are always needed and

welcomed.
